2. The **Terms of Reference (TOR)** of the State Level PBR Quality Evaluation Monitoring Committee shall be as under:

- To oversee the quality of PBRs on basis of the PBR Quality Evaluation Framework (**Annexure- I**) developed by the National Biodiversity Authority, Chennai. And in accordance with the provisions of the Biological Diversity Act, 2002 and Assam Biodiversity Rule, 2010.
- To interact with the relevant stakeholders who are involved in the preparation of PBRs or as it deems fit.
- To submit quarterly evaluation report to the Assam State Biodiversity Board dully authenticated by all the members. The Board in turn shall furnish the report to the NBA, Chennai.
- The Board may amend the TOR, if required.



3. The Committee shall meet once in every quarter.
4. The members shall be paid sitting fee and local travel expenses as per existing norms.
5. The tenure of the State Level PBR Quality Evaluation Monitoring Committee shall be **two years** from the date of issue of this order.
