NOTIFICATION

Whereas the campus of the State Horticulture Research and Development Station (SHR&DS) in Krishnagar, Nadia has a rich Gangetic alluvial soil that nurtures heritage of indigenous horticultural germplasm of orchard trees. The campus is home to more than fifty varieties of mango, seven varieties of guava, and five varieties each of lime, litchi, water apple, and Kul. In addition to horticultural crops, the campus also nurtures several indigenous and medicinal plants. Furthermore, the canopy of the entire campus provides a good habitat for various avian fauna, butterflies, and other insects.

AND WHEREAS to strengthen the biodiversity conservation in the campus of the State Horticulture Research and Development Station, while keeping the horticulture extension and horticultural research intact, the State Government, upon recommendation of the West Bengal Biodiversity Board, has felt it necessary to declare the area as the State Horticulture Research and Development Station Biodiversity Heritage Site.

AND WHEREAS the collection of species of plants, animals and microbes from the campus of the State Horticulture Research and Development Station requires to be regulated as per the provisions of the Biological Diversity Act, 2002 and West Bengal Biological Diversity Rules, 2005.

AND WHEREAS no-objection regarding declaration of the campus of the State Horticulture Research and Development Station as Biodiversity Heritage Site has been issued by the Department of Food Processing Industries & Horticulture, Government of West Bengal.

Now, therefore, in exercise of the powers conferred under sub-section (1) of section 37 of the Biological Diversity Act, 2002 and sub-rule (2) of rule 20 of the West Bengal Biological Diversity Rules, 2005, the Governor is hereby pleased to declare the campus of the State Horticulture Research and Development Station, Krishnagar, Nadia district as the State Horticulture Research and Development Station Biodiversity Heritage Site.

The details of the area and boundary of the State Horticulture Research and Development Station Biodiversity Heritage Site is given below:-

This notification shall come into effect from the date of its publication in *The Kolkata Gazette*.
