2. CONFIRMATION OF MINUTES OF THE 9th MEETING OF NATIONAL BIODIVERSITY AUTHORITY (Appendix 1: Page No. 208)

1. The minutes of the 9th Authority meeting was sent to all the members by speed post vide Lr No 8/2/218/2003-07-08 NBA/1686-1701 dated 09.07.2007. An agenda submitted by **Dr S. K. Sharma**, Adviser, (AY) Ministry of Health and Family Welfare, Department of Ayurveda, Yoga and Naturopathy, Unani, Siddha and Homoepathy (AYUSH) vide Do No. L. 873/Adviser (Ayurveda)/2007 dated 17th August, 2007 to include the issues sent and same was incorporated in the minutes. The Members of the Authority appreciated the achievements made during the period and the minutes of the 9th Authority meeting was approved by the members unanimously.

3. ACTION TAKEN ON THE MINUTES OF THE 9th MEETING OF NATIONAL BIODIVERSITY AUTHORITY

The action taken on the 9th authority meeting was placed for discussion. The members of the Authority carefully went through the action taken report and noted the contents.

One of the Members **Dr Sajwan** invited certain clarification on the Agenda Item No 3: 1. On the letter submitted by the National Medicinal Plant Board: item present on **the Additional Agenda for the Nineth Authority meeting with the permission of the Chair** (on page 46 of the "10th Authroity meeting Agenda" on Action taken Report).

Earlier Minutes on the 9th Authority on "The issue of permitting export of Indian Medicinal Plants for WHO Indian Medicinal Plants Garden, Geneva" and it was agreed already to prepare and sign MOU between the AYUSH and WHO for the above.

For the above purpose, the NBA has to prepare a "legally vetted draft MOU" prepared from the agreements already finalized for applicants for Access, Transfer of Research Results, IPR and Third Party Transfer of bioresources to Indian Medicinal Plant Board for executing MOU between AYUSH and WHO.

Dr S. Subramaniam invited certain clarification on the Agenda item No 2. 2. *Biodiversity Conservation Park at Thiruchrapalli by NBA*: item present on **the Additional Agenda for the Nineth Authority meeting with the permission of the Chair** (on page 46 of the "10th Authroity meeting Agenda" on Action taken Report).

The Chairman NBA replied to the above query that NBA has already projected funds for establishing "Biodiversity Conservation Park" in the 11th Five Year Plan. Once the funds are available, the same will be executed by NBA in selected places in India.

4. DISCUSSION ON THE AGENDA FOR 10th AUTHORITY MEETING

Agenda 1: Audit Report on the Accounts of National Bio-diversity Authority, Chennai for the year 2005-06 submitted by Principal Director of Audit (Scientific Departments)

Comments on accounts:

i) Format of accounts.

The National Bio-Diversity Authority did not prepare the Annual Accounts for the year 2005-06 in the common format prescribed for autonomous bodies. The .Balance Sheet was not segregated as capital account, current liabilities and provisions and reserves on the liabilities side. The assets side was also not segregated as fixed assets, current assets, loans and advances, investments, etc.

ii) Accounting policies and Notes to Accounts.

The Significant Accounting Policies and Notes to Accounts which form part of Annual Accounts were not appended.

iii) The NBA revised its Annual Accounts at the instance of audit.

Other points of minor nature are being brought to the notice of the Management, through a separate Management letter.

The members of the authority noted the comments on the accounts by the Principal Director of Audit and informed that the Annual accounts for the year 2006-2007 should be submitted in the common format prescribed for the autonomous bodies as well as significant accounting policies and Notes to accounts should be appended by NBA.

Agenda 2: Comments on the Guidelines prepared by the Expert Committees for Notification on

1. Access and benefit sharing, 2. Enforcement of Biodiversity Act; 3. Endemic, Endangered and Threatened and 4. Designation of National Repository

The Secretary informed that NBA needs to develop a guideline for access of bioresources by foreigners. Any foreigner to access biodiversity of India required to be monitored and shall work with an Indian Research agency and abide by the protocol as proposed in the Expert committee to scrutinize the application for approval. Also he stated that the Guideline for access and Benefit sharing may be finalized once again by conducting a meeting with experts drawn from different agencies (ABS meeting proposed by NBA during December 2007)

With reference to Enforcement of Biological Diversity Act the Secretary informed that NBA needs to develop a guideline to prevent misappropriation and unauthorized access and use of Biological Resource, their derivatives and products and associated Traditional Knowledge, innovations and practices by designation of Officers for enforcement of Biological Diversity Act 2002 as per section 61 a. and the necessary corrections pointed out during the 9th Authority meeting will be carried out before being sent to the Ministry for notification.

The Secretary informed that the Guidelines on criteria to categorize and list threatened species in India the necessary clarifications will be made as proposed

With regard to the finalization of the Guidelines on designation of National Repository and guidelines for the structure and functions of these repositories under Biological Diversity Act the Secretary assured that the NBA will write to all concerned organizations mentioned in the draft to act as National Designated Repositories.

The Authority, after careful examination of the comments by the Additional Director, Ministry of Environment and Forests, informed that the Guidelines on "Criteria to categorise and list of threatened species in India" to be sent to Wildlife Board of India to examine as well as the comments on the agreements by MoEF should be incorporated and sent immediately for further necessary action. Also other draft Guidelines such as Repositories, Enforcement of Biodiversity Act, Access and Benefitsharing are corrected according to the comments made by MoEF and sent back to the Administrative Ministry for further action.

Agenda 3. Request from R. Dewan & Co., Trademark and Patent Attorneys Mohan Dewan

The Secretary, NBA informed the Authority that the Honorable Attorney prayed on behalf of the applicant that the "SCHEME OF SECTION 6 OF THE ACT PROVIDES INTERALIA IN SECTION 6(2): "The National Biodiversity Authority may, while granting the approval under this section, impose benefit sharing fee or royalty or both or impose conditions including the sharing of financial benefits arising out of the commercial utilization of such rights."

Also the Attornery mentioned in his letter to NBA that "Therefore, it is clear that the act does not make it mandatory upon the NBA to impose agreements, and, terms and conditions, at the time of granting of an approval. The term 'may' used in the section gives a discretion to the NBA to impose or not to impose any conditions and, also vary the conditions depending upon the type of applicant." Therefore, the condition of signing an agreement by imposition of penal royalty and requirement of reporting should be put up only in rare cases making judicious use of word 'may' of the act and not

mandatory for each applicant." Also the Attorney has suggested that "Our alternative suggestion is that if the Govt. wants to levy charges for use of National Bioresources then it should be leviable to all using national bioresources whether patentee or not and may be implemented at a authority like FDA, where permissions are sought for commercial exploitation."

The Secretary informed that the above request was put up for Legal Opinion by NBA. The Asst. Solicitor General of India states that "The discretion that is provided under section is only in relation to imposing benefit sharing fee/royalty and not to decline to exercise the discretion vested with the National Biodiversity Authority. In view of the fact that the discretion is vested with the authority, the applicant is not entitled to compel the authority to exercise the discretion in a particular manner. So far as the act remains in the statute book, the NBA has discretion to impose restriction/condition which cannot be questioned".

Also NBA has informed the Honorable Attorney to appear for a personal hearing on 12.10 2007 which could not be materialized due to short notice. It is proposed by Honorable Attorney another date for personal hearing.

The Secretary, NBA informed that the applicant may be requested to appear for personal hearing once again to solve the issues between the applicant and NBA as well as the legal opinion obtained from the Legal Advisor appointed by NBA in this case.

The Authority, after careful examination of the request, approved the suggestion of requesting for one more request for personal hearing to solve the issue between the applicant and the NBA. Also the Authority after careful examination of the legal opinion submitted by the Legal Advisor appointed by NBA, in connection with the sharing of benefit by the applicant, approved the legal opinion obtained and informed that the NBA has the right to impose benefit sharing on case to case basis as per the Biological Diversity Act, 2002.

Agenda 4: Permission to grant pay of Secretary, National Biodiversity Authority to Dr K. Venkataraman

The Authority, after careful examination of the request for Permission to grant pay of Secretary, National Biodiversity Authority to Dr K. Venkataraman, deliberated that it is not permissible under FR 49 as per the O.M of DOPT since the status of NBA is that of a public sector undertaking/autonomous body/registered society. Hence, Dr. K. Venkataraman is not eligible to draw the Higher Pay Scale of Secretary in NBA. However, the Authority suggested that Dr Venkataraman may be suitably compensated by anyother means for his contributions to NBA as

consultation. The Authority however reiterated that the appointment of Secretary should be expedited.

The Secretary informed that the applications approved by the Authority were placed before the Expert Committee for Determination of Benefit Sharing and Benefit Sharing decided which was intimated to the applicants. The applicants have made representations concerning the Benefit Sharing to NBA.

The following are the comments on the applications are placed again before the Expert Committee for their comments.

1. Nandan Biomatrix Limited, Hyderabad is engaged in R & D of Medicinal Plants, cultivating Medicinal Plants especially Safed Musli. Nandan Biomatrix has a State of the art Resource Centre at Zaheerabad, Medak Andhra Pradesh. ICRISAT has also partnered with the company in R&D. Nandan Biomatrix has informed that the company does not use any natural resources collected from the wild and hence Nandan Biomatrix requested that they may be exempted from sharing any benefits through their R&D program. They have also written to NBA that a one time payment of Rs.10,000/- may be accepted by NBA as a goodwill gesture for the Biodiversity Fund and grant the patent to Nandan Biomatrix by executing necessary agreements. They have also prepared and submitted a draft agreement in this regard.

Earlier Nandan Biomatrix had applied in Form III dt.22-05-2006 which was placed before the Expert Committee to evaluate the Access, Patent, Transfer of Research Results and Material Transfer Applications" meeting held on 03-10-2006. Clarifications were sought on certain details of IPR. The above application was placed before the 8th Authority Meeting which approved the IPR. The Expert Committee for Determination of Benefit Sharing fixed the Royalty Fees. A provisional approval letter was sent to the applicant along with a draft agreement copy to the applicant.

Comments of the EC: The Expert Committee opined that no exemption whatsoever be granted to Nandan Biomatrix Limited. The EC also did not accept the Nandan Biomatrix Limited's proposal of One time payment of Rs.10, 000/- to NBA. Nandan Biomatrix Limited should be advised to sign the Agreement (Benefit Sharing incorporated) as per the minutes of the Expert Committee on Benefit Sharing.

The Authority after careful examination of the comments of the Expert Committee approved the comments made by the Expert Committee for further necessary action by NBA.

2. Mr. Mohan Dewan, R.K.Dewan & Co., (Patent Attorney law firm representing the Applicant Dr. Pawan Pankaj Lalsing) submitted that he has placed on behalf of his client a request before the Authority on the 5% royalty for Benefit Sharing and he has raised certain issues pertaining to Patents in regard to Biological Diversity Act, 2002. On the issue of 5% royalty, Mr. Mohan Dewan has quoted Section 6 (2) of the Biological Diversity Act, 2002 which says that "The National Biodiversity Authority may, while granting the approval

under this section, impose benefit sharing fee or royalty or impose conditions including the sharing fee or royalty or both or impose conditions including the sharing of financial benefits arising out of the commercial utilization of such rights".

Comments of the EC: The Expert Committee opined that 5% of the Royalty if the Patent is licensed to others or 5% of the net sales of the company in the event of commercial production by the company as decided earlier may be intimated to the applicant.

The Authority after careful examination of the comments of the Expert Committee approved the comments made by the Expert Committee for further necessary action by NBA. Also the authority approved the legal opinion provided by the Asst. Solicitor General of India to NBA and the NBA has every discretion to impose restriction/condition which cannot be questioned.
