## **NOTIFICATION**

WHEREAS Namthing Pokhari is a Himalayan natural wetland (pond) with traditional belief, taboos covering an area of 11.91 Acre in Selpu Khasmahal, J.L. No. 62, Sittong III Gram Panchayat, Kurseong Block, District Darjeeling and offers refuge to Himalayan Salamander (*Tylototriton himalayanus* Khatiwada, Wang, Ghimire, Vasudevan, Paudel, Jiang, 2015) locally called as 'Goro/ Gora/ Pani Kukur' which is an evolutionary significant species endemic to Indo-Nepal Himalayan region and listed under Appendix II of CITES, Schedule I Part D of the Indian Wildlife (Protection) Amendment Act, 2022 and Vulnerable as per IUCN with decreasing population trend.

AND WHEREAS to strengthen the biodiversity conservation and to stem the habitat degradation in the pond, the State Government, upon recommendation of the West Bengal Biodiversity Board, has felt it necessary to declare Namthing Pokhari and surrounding area as Biodiversity Heritage Site.

AND WHEREAS the collection of species of plants, animals and microbes from the Namthing Pokhari and surrounding area requires to be regulated as per the provisions of the Biological Diversity Act, 2002 and West Bengal Biological Diversity Rules, 2005.

AND WHEREAS no-objection regarding declaration of Namthing Pokhari and surrounding area as Biodiversity Heritage Site has been issued by the office of the District Magistrate of Darjeeling.

Now, therefore, in exercise of the powers conferred under sub-section (1) of section 37 of the Biological Diversity Act. 2002 and sub-rule (2) of rule 20 of the West Bengal Biological Diversity Rules, 2005, the Governor is hereby pleased to declare Namthing Pokhari and surrounding area as Namthing Pokhari Biodiversity Heritage Site.

Management of the BHS shall be done by a Namthing Pokhari Biodiversity Heritage Site Management Committee constituted by District Magistrate, Darjeeling involving Kurseong Block Biodiversity Management Committee (BMC), Darjeeling District Level BMC, Forest Department, Fisheries Department, Land and Land Reforms Department, Public Health Engineering Department, Irrigation and Waterways Department, experts in the relevant field, other stakeholders, along with representatives from West Bengal Biodiversity Board, with overall supervision of the District Administration.

This notification shall come into effect from the date of its publication in The Kolkata Gazette.
