#### ORDER

As per direction of the Principal Bench of National Green Tribunal read as paper 1<sup>st</sup> above, the National Biodiversity Authority with the approval of Ministry of Environment Forest & Climate Change constituted Peoples Bio diversity Register (PBR) Monitoring Committee at National Level to evaluate the quality of PBRs prepared by the State on sample basis. Considering the practical difficulty of conducting an extensive evaluation of large number of Peoples Bio diversity Registers, the Chairman National Biodiversity Authority as per his letter read above has requested the State Government to constitute a 5 -7 members State Level PBR Quality Evaluation Monitoring Committee, comprising of subject matter experts including superannuated forest service officers for the verification of PBR's in the State by evolving a suitable mechanism and also to support the National PBR Monitoring Committee appropriately.

2) As per letter read as 3<sup>rd</sup> above, the Chairman, Kerala State Biodiversity Board requested Government to constitute State Level PBR Quality Evaluation monitoring Committee in the State for the verification of PBRs and submitted a list of experts to be nominated in the committee.

- 3) In this circumstances, Government are pleased to constitute the State Level Peoples Biodiversity Register Quality Evaluation monitoring Committee consisting of the following members.

# Terms and reference of the Committee

- (a) To oversee the quality of PBRs by evolving a suitable mechanism based on the PBR Quality Evaluation Framework developed by National Bio Diversity Authority
- (b) To interact with relevant stakeholders who are involved in the preparation of PBRs or as it deems fit;
- (c) To support the National PBR Monitoring Committee appropriately.
- 5) TA & DA of the committee shall be as per Government norms. Honorarium shall be Rs. 2,000/- per sitting.
