Biological Diversity Act, 2002 No. GVN/2025/01/VPS/102018/SF-13/W:- WHEREAS mangroves found within the areas of Guneri village, Tehsil Lakhpat of the Kutch District is a unique site in respect of the Biodiversity of the State, which have significant importance and requires immediate conservation;

AND WHEREAS the Government of Gujarat has decided to notify the said area as a Biodiversity Heritage Site;

AND WHEREAS the Guneri Juth Gram Panchayat has been consulted by the concerned Authority for the purpose of notifying the Inland Mangrove of Guneri as Biodiversity Heritage Site;

NOW, THEREFORE, in exercise of the powers conferred by sub-section (1) of section 37 of the Biological Diversity Act, 2002 (18 of 2003) and Rule 13(C) of the Gujarat Biological Diversity Rules 2010, the Government of Gujarat, on recommendation of the Gujarat Biodiversity Board (GBB), hereby notifies "Inland Mangrove of Guneri" in the District of Kutch as a 'Biodiversity Heritage Site' (Hereinafter referred to as "the BHS area") of Gujarat, as shown in the Schedule appended hereto, subject to following condition, namely:-

- (1) Any change in land use of the area notified under the schedule shall be prohibited.
- (2) The collection of the Species of plants from the area shall be prohibited except with the approval of Gujarat Biodiversity Board and only for the purposes of:
 - i. Scientific Research;
 - ii. Herbarium and Museum;
 - iii. Propagation; and
 - iv. Any other Scientific investigation.

Such that the collection will not destroy the structure and sanctity of the BHS area.

- (3) The Gujarat Biodiversity Board shall:
 - i. Undertake the Management Plan for Conservation of the natural flora and fauna of the BHS area;
 - ii. Respect the Rights and Privileges of Local People shall be respected in the Management of the Sites;
 - iii. Conduct capacity Building Programme(s) for front line staff of Forest Department, local forest dwellers and Tribals to conserve Biodiversity;
 - iv. Propagate Species for in-situ and ex-situ conservation and rehabilitation; and
 - v. Provide full participation of local people in the Management of this site.
