CIRCULAR

Sub: Instruction to Applicant for filing an application for Access to Red Sanders
from Cultivated Sources or Auctioned/Seized Red Sanders

In supersession of all previous office orders and circulars issued on this subject, the following instructions are issued for the applicants:

1. Any person who intends to access the Red Sanders from cultivated / Artificially Propagated sources or from auctioned Red Sanders, in any form, for commercial utilisation needs prior approval of the NBA as per section 3 of the Biological Diversity Act, 2002, as amended in 2023.
2. Applicants covered under Section 3(2) shall apply to NBA in Form-2 through the online ABS filing portal at: <https://absefiling.nic.in/NBA/login/auth> and shall pay the prescribed application fee of INR 20,000/- as per Rule 13 of the Biological Diversity Rules, 2024.
3. At the time of submitting the application, the applicant shall also submit the duly signed checklist along with the self-attested supporting documents, as provided in the Annexure to this Circular, either through the online portal or by email: secretray@nba.nic.in / techbs@nba.nic.in. The Annexure -1 is applicable for Red sander from Cultivated Sources and Annexure -2 is applicable for auctioned/Seized Red Sanders.
4. No payment should be made other than the application fee of Rs 20,000 to NBA without receiving any communication from NBA. In case any payments are made, the same shall not be taken into account.
5. The application fee and any Access and Benefit Sharing (ABS) amount paid shall be non-refundable and shall not be adjusted against any future application or transaction.
